




## Summary

### 1. What was your experience level with Shibboleth and federated AAI before the training?




New to Shibboleth and federated AAI	<b>10</b>	76.9%

I now feel confident I can configure a Shibboleth SP for use in a Virtual Organization with Attribute Aggregation.

I feel can confidently install and configure a Shibboleth Service Provider but not for production: first I'd want to install one for testing and experimenting (including checking how it behaves on failure of providers, network, etc)

I knew Shibboleth from the beginning to be quite complex. Configuration was much simpler than anticipated.

The training provided practical hands-on experience.

I have detailed instructions, examples and direct contact to the people that can help me in case of problems

All the important things seemed to be covered. I'll surely keep the slides from the training as a reference.

The practical experience gained during the workshop allows me to confidently install Shibboleth

We went through the whole process from start to finish so I know what to do now. The slides were also shared with us which contain all the steps needed to setup so I feel confident I can reproduce our example from the workshop on a production machine.

IT not being the primary field of my expertise and activities, I would need some additional backup if I were to attempt an installation. Also I do not have systemic administration privileges at my home organisation. Having said this, the workshop was very well planned and executed and it provided sufficient overview as well as detail information.

We now have a clear path of what to do next to concretely integrate our web portal in an identity federation and more hands on experience.

Our team is interested in some form of AAI (not necessarily ELIXIR-AAI) and this training was very useful to introduce the idea of federated access.

Really good introduction to Shibboleth and how it's configured. Although we're using Spring Security, knowing the alternatives is important. Especially also the parts about Apache integration and how to get access to attributes from a script. I also found it useful to see how the attributes are used in practice.

The installation of Shibboleth is relevant to our team as we are interested in providing access of multiple institutions to our service without the need to create a separate account.







Getting knowledge about ELIXIR AAI helps developing services


Our organisation aims to implement a campus-wide access using ELIXIR-AAI therefore the services we develop will integrate into that.








**14. How do you think you, your team and the company benefited from you attending the Dariah-specific training on Day 2?**





We intended to use ELIXIR AAI anyway for our software, but going to the course has made me think about utilizing the PERUN groups features, as well as understanding what the limitations on attributes we can request will be.

As stated above, we were already considering Shibboleth before coming to the workshop.

The training provided detailed information about its functioning as well as provided personal contacts to experts in case we will need additional support/information with implementation/installation.
