Community Clouds Drivers

- European Digital Sovereignty / European data space
 - data storage and processing independence from non-European entities
- Interoperability / Data sharing issues
- vs Hyperscalers growth
 - vs Regulatory issues
 - See Cloud Act vs GDPR, Shrems II, Privacy Shield (Plus)

Community Clouds Value

- Personally Identifiable Information (PII) sensitive use cases
 - Use cases with strict requirements (e.g. medical research)
- International collaboration use cases
 - Institutions leveraging community clouds can share their data among them without restrictions/lock ins
- NRENs high speed networks leverage
- Fostering of know-how on cloud technologies
 - In a world of converged cloud-network technologies



Community Clouds federation?

The interest of NRENs operating Community Clouds is to evaluate the advantages and feasibility of federating the Community Clouds

- focusing on cloud platforms' technological aspects
- breaking data silos models
- fostering interoperability between Community Cloud services



Community Clouds for NRENs – Lines of Action

Define a Community Cloud AAI common framework

- common practices on user registration, authentication and authorization
- eduGAIN
- AARC Blueprint Architecture
- Creation of a "Community Cloud Toolkit"
 - high level, implementation independent, architectural blueprint
 - interoperability and compliance to AAI and security principles
 - tools and documentation aimed at NRENs and institutions who wish to set up a Community Cloud at their premises, with a highly automated, open and federated approach



Community Clouds for NRENs – Lines of Action

- Prototype the operation of service federation of Community Cloud infrastructures
 - consider initially key services like videoconferencing, to thereafter encompass other cloud services
- Ensure that knowledge and tools are exchanged between NRENs on security topics
- Work collectively on a comprehensive open source accounting platform for Community Clouds, targeting the current and emerging infrastructural cloud technologies and adaptable to different workflows



GÉANT strategy alignment

The GÉANT strategy 2021-2026 document resonates with the "Community Clouds for NRENs" approach:

- Offering open and innovative infrastructures
- Collaborating and sharing knowledge
- Prefer community supplied services to commercially procured services
- Continuous development of the existing infrastructure and assessment of new technologies


